

Community Opinion Survey March 2022 Results & Analysis

April 2022





The second Ottershaw Neighbourhood Forum Community Opinion Survey received a very good response (over 300) across a wide section of the village, although it was again noted that the majority of respondents were in the age bracket of 40+. This has highlighted that more work needs to be done to engage the younger elements of our Neighbourhood Area.

We will be using the analysis resulting from the survey responses as a key element to finalise our Ottershaw Vision for the Future and direct our approach as we move forwards developing our Neighbourhood Plan.

Some of the key issues to address as a result for us now include:

- Gaining a better understanding of our existing facilities, their shortcomings and their potential.
- Work to better define requirement for the proposed new GP Surgery/Health Centre in Ottershaw.
- Building upon your comments to define the look and feel of our village centre.
- Developing policies to ensure any developments fit well with the surrounding area.
- Looking to develop policies for improving, expanding & connecting our foot & cyclepaths.
- Working with other residents groups to achieve the best results for traffic congestion, speeding, rat runs, security etc.
- Providing more information to ensure the community fully understands Green-Belt, SANGs and open spaces such that we can develop policies which can offer protection.

We look forward to working with the community to continue towards creating a viable plan for the future of our village, that will enhance the village that we know and love, whilst securing its future and making way for the next generation to enjoy what we have always appreciated.



Question 1.2 How long have you lived in the Ottershaw Neighbourhood Area?















Question 1.4 Please indicate your age group:

SECTION 2 ROADS, FOOTPATHS AND CYCLEPATHS



Parking restrictions need to be investigated in the busier parts of our village








 The installation of a range of traffic calming measures, possibly including illuminated speed signs, give way to oncoming traffic, width restrictions, speed slowing platforms, etc






Question 3.5 The village centre to remain but with features such as additional retail, parking and toilets with less able and childcare facilities located nearby/opposite the Village Hall?








Question 3.2 Would you consider a new village centre desirable, located elsewhere?










Question 4.1 The current schooling establishments in Ottershaw are near or at capacity, and with population growth from now on, more capacity will be needed. Would you wish to:















Question 7.1 Is anti-social behaviour and vandalism in the village of major concern to you?














Question 9.3 What minimum provision for off street parking (excluding garage and including visitor space) should be made for properties of different sizes?




